ORAL ORDER

2 16-10-2019 This is an application for modification of order, dated 30.07.2019, passed in Cr. Misc. No. 47179 of 2019 in connection with Nardiganj P.S. Case No. 189 of 2017, pending in the Court of the Additional Chief Judicial Magistrate, VI, Nawada, by which the petitioners were granted pre-arrest bail, but, they could not surrender before the Court below within the stipulated time of four weeks due to the death of mother of
