The petitioner filed this writ petition for a direction to
the Director, Consolidation to dispose of the case of the
petitioner pending before him.



The learned counsel for the State has got no objection.

It appears that earlier the consolidation proceeding was stayed or stalled but now the Government vested power in the Director, Consolidation to dispose of the pending cases.
