2 19-11-2019 Learned counsel for the petitioner has at the outset informed this Court that against the improper rejection of membership application by the Managing Committee of the respondent PACS, in CWJC No.



22124/2019 a case being Membership Dispute Case No. 148 of 2019 and due to non-consideration of the application for Membership in CWJC No. 22125/2019 another case bearing No. 130 of 2019 in terms of Section 48 of the Bihar Cooperative Societies Act, 1935 has been filed before the respondent no. 2 and those are pending consideration without any progress.

In the given facts and circumstances of the case, both the writ applications are being disposed of with a direction to the Registrar, Cooperative Societies, Bihar, Patna (respondent no.2) to fix a date of hearing in Membership Dispute Case No.148 of 2019 and Case No.130 of 2019 within one week from the date of receipt/production of a copy of this order and dispose of the same as early as possible if possible within three weeks from the date of receipt/production of a copy of this order and shall consider any other relief which may be prayed by the petitioners.
