order dated 14.11.2014 passed by the Circle Officer, Amarpur in Mutation Case No.1302 of 2014-15 and the order dated 22.12.2016 passed by D.C.L.R., Banka in Mutation Appeal No.32 of 2015-16 by which the petition of the petitioner for mutating his name has been dismissed.
