ORAL ORDER

2 06-12-2019 The petitioner has a grievance that his private land is being attempted to be utilized for drainage purpose leaving out a public land, which is available at Mauza Sandalpur, Aadiwasi Colony in the district of Patna. The description of the land has



been given as Khata No. 640, Plot No. 1271 and 1273.

This Court, in a proceeding under Article 226 of the Constitution of India, may not record a finding, based on affidavits, that the land in question is private land of the petitioner, which is being attempted to be utilized forcibly by the respondents for construction of drainage.

The petitioner has remedy by making an application before the appropriate Public Grievance Redressal Officer under Bihar Right to Public Grievance Redressal Act, 2015.

This application is accordingly disposed of with an observation that the petitioner shall be at liberty to approach appropriate forum in accordance with law.
