This application has been filed by the respondents for a direction upon the writ petitioners to issue similar order in respect of the petitioners in OA No. 71 of 2008 and respondents in WPCT 6 of 2011. The petitioners have disclosed a communication dated 17th April, 2019 wherefrom it appears that the order of Lucknow Bench has been accepted by the Government of India (Zoological Survey of India).

An adjournment is prayed for on behalf of the writ petitioners.

We adjourn this matter with a specific direction that the petitioners shall file a short affidavit in WPCT 6 of 2011 stating whether they are willing to give the similar benefits which the Lucknow Bench had granted to persons who are claimed to be similarly placed as that of the respondents in this proceeding within a period of 10 days from date.

The matter stands adjourned till 20th August, 2021 as heard in part.

The matter shall appear at the top.
