1. The limited grievance which the petitioner has raised in the present writ petition is that the petitioner's claim for promotion from the post of Mali to the Post of Gramin Uddyan Vistar Adhikari.
2. According to the petitioner, The D.P.C, in this regard, has already convened and the petitioner was also considered and as has also been found eligible for promotion and the matter has further processed for issuance of order of promotion. That the matter is now pending consideration before the respondent No. 1 for quite some time and a formal order only has to be passed, therefore, the petition has been filed seeking for appropriate direction in this regard.
3. Given the limited nature of dispute that the petitioner has raised this court is of the opinion that ends of justice would meet if the

respondent No. 1 is directed to pass an appropriate order within a period of 90 days from the date of receipt of copy of this order. So far as the promotion of the petitioners are concerned from the post of Mali to the post Gramin Uddyan Vistar Adhikari. It shall be the responsibility to the petitioner to apprise the respondent No. 1 so far as the order passed by this court is concerned.
