1. This is the second bail application filed by the applicant who is in jail in connection with Crime No.39/2015 registered at Police Station Darbha, District Bastar for the offence punishable under Section 20-B (ii) (C) of the NDPS Act. The first application being MCRC No.8488/2018 was rejected on merit vide order dated 17.12.2008.
2. Having heard counsel for the parties prima facie it appears that 100 Kg. of cannabis was seized from the possession of the accused/applicant and as on date no change in the circumstances has been brought forth by him, this Court is not inclined to grant bail to the accused/applicant. Accordingly this application is hereby rejected.
3. The trial Court is however directed conclude the trial as early as possible preferably within a period of six months from the date of receipt of copy of this order.
