1. Ignoring the default pointed out by the registry, with the consent of the parties the matter is heard finally at the motion stage itself.
2. The limited grievance of the petitioners is that **petitioners** are entitled for the benefit of Kramonnati on completing 10 years of service which **petitioners** have completed but **petitioners** have not been given the same till date.
3. Given the limited grievance raised, let the **petitioners** make detailed representation in this regard to respondents 3 & 4 who in turn shall scrutinize the same and pass a suitable order in accordance with the rules governing the field of Kramonnati. It is expected that an appropriate order shall be passed within a period of 4 months from the date of receipt of representation of the petitioner.
4. With the aforesaid observation, writ petition stands disposed of.
