1. The challenge in these writ petitions is to the advertisement Annexure P-1 dated 19.12.2018 whereby the respondents have invited applications for the post of Sub-Engineer (Civil) in the different categories.
2. At the outset, the counsel appearing for both the parties submit that the issue involved in these writ petitions have already been decided by this Court in a bunch of writ petitions leading case of which was WPS No. 2229 of 2019 and other connected writ petitions decided on 25.04.2019.
