1. Ignoring the default pointed out by the Registry, with the consent of the parties, the matter is heard finally at motion stage and disposed off.
2. Challenge in this Petition is that though the petitioners were initially appointed as Shiksha Karmi Grade-III and have subsequently been absorbed to the Education Department, they have by now completed 10 years of service and therefore they are entitled for the benefit of Kramonnati as per rules governing the field, however, the respondents till date have not granted the said benefit to the petitioners.
3. Given the limited grievance which the petitioners have raised, let the petitioners made a suitable representation to the Respondent No. 04 within a period of three weeks from the date of receipt of certified copy of this Order and the Respondent No. 04, in turn, shall take a decision on the granting of Kramonnati to the petitioners within a further period of 90 days.
4. The Writ Petition, accordingly stands disposed off.
