Order On Board**19.06.2019**

1. Since these petitions arise from same crime No., these bail petitions are being disposed off simultaneously.
2. These are first bail application under Section 439 of the Cr.P.C. preferred by the applicants before this Court and no other bail application is pending before any other Court.
3. Perused the case diary provided by the learned counsel for the State in connection with crime No. 177/2019 registered at Police Station – New Rajendra Nagar, District- Raipur, (C.G.) for the offence punishable under Section 4, 5, 7 of Prevention of Immoral Trafficking Act, 1956.
4. Case of the prosecution, in brief is that Krishna Kumar Patel posted as CSP at Purani Basti, Raipur on 04.05.2019 he received information that applicant Kiran Sharma is operating sex racket at Impresia Colony, Amlihdih. To raid, a team was constituted. Pointer Amit Kumar Jain was given 4 notes of Rs. 500/- denomination with specific numbers. Pointer met with applicant Kiran Sharma. Applicant Kiran Sharma sent him to applicant Geeta Soni. He gave Rs. 2000/- to applicant Geeta Soni for deal for providing a prostitute. Bearing same number of notes were seized from applicant Geeta Soni. In the house of applicant Kiran Sharma, applicants Nisha Khan, Taj Noushad were also present who were committing prostitution. During the investigation it was found

that applicant Geeta Soni was also participating in dealing for providing the girls.

5. Learned counsel for the applicants submits that applicants have no criminal background, they are innocent and have been falsely implicated in the present case, therefore, they shall be released on bail.
6. On the other hand, learned counsel for the State opposes the bail application, however, submits that there is no antecedent against the applicants.
7. Looking to the facts and circumstances of the case, looking to the material available on record, It is directed that if applicant **Nisha Khan @ Rahmunisha** and applicant **Taj Noushad** each furnishes one solvent surety for a sum of Rs.25,000/- each along with a personal bond of Rs. 25,000/- to the satisfaction of the concerned Trial Court with the condition that she will appear before the Trial Court at 11:00 am as and when directed till trial and she would cooperate during the trial, she shall be released on bail.
8. Looking to the facts and circumstances of the case, looking to the material available on record against applicants Geeta Soni and Kiran Sharma (Sahu), their bail applications are rejected.
