Given the limited grievance raised, let both the petitioners make detailed representation in this regard to respondents 3 & 4 who in turn shall scrutinize the same and pass a suitable order in accordance with the rules governing the field of Kramonnati. It is expected that an appropriate order shall be passed within a period of 4 months from the date of receipt of representation of the petitioners.
