2. The modification sought for is to the extent that the name of the Petitioner No. 2, in the cause-title, has been wrongly got typed as "Pradha" instead of "Prabha".

3. Considering the nature of modification sought for and the fact that there is no dispute so far as the name of the petitioner No. 2 being **“Prabha”** the MCC deserves to be allowed.
