Hon'ble Smt. Justice Rajani Dubey**Order on Board****02.12.2019**

- The accused/applicants have moved this first bail application under Section 439 of the Code of Criminal Procedure for

releasing them on regular bail during trial in connection with Crime No. 23/2019 registered at Police Station – Rengakhar, District Kabirdham (C.G.) for the offence punishable under Sections 420, 467, 468, 471 & 34 of IPC.

- It is the case of the prosecution that, one Satyaprakash Sharma made a written complaint to the Superintendent of Police, Kabirdham, alleging that applicant Madan Lal has been appointed Shiksha Karmi on the basis of false mark-sheet of 12th class. During investigation from disclosure statement of Madan Lal, it reveals that he has given Rs. 15,000/- to Suman Baghel for obtaining false mark-sheet. It is also alleged that the memorandum statement of Suman baghel disclosed that she obtained false mark-sheet through applicant Dhunnu Lal Sarwa. After completion of investigation, alleged offences have been registered against the applicants and the applicants have been arrested.
- Learned counsel for the applicants submit that the applicants have been falsely implicated in the crime in question. They further submit that as the applicants Madan Lal, Suman Lal Baghel & Dhannu Lal Sarwa are in custody since 28.08.2019, 27.08.2019 & 28.09.2019 respectively, and the trial is likely to take some time for its final disposal, they may be released on bail.
- On the other hand, counsel for the State opposes the bail application.
- I have heard learned Counsel for the parties.
- Taking into consideration the nature and gravity of the offence, detention period of the applicants facts and

circumstances of the case, the fact that charge-sheet has been filed and the offence is triable by Judicial Magistrate First Class and the trial is likely to take some time for final disposal, I am inclined to release applicants on bail.

- It is directed that the applicants shall be released on bail on executing a personal bond for a sum of Rs. 25,000/- each, with one surety for the like amount to the satisfaction of the Trial Court for their appearance before the said Court as and when directed.
