PER COURT :-

1. The learned Counsel for the applicants submits that, the applicants are ready to waive the interest in the event their cross objections are allowed and the amount of compensation is enhanced.

2. In view of the submission made, the delay caused in filing cross objections is condoned. It be registered in accordance with law. It is clarified that, in the event the amount of compensation is enhanced in the cross objections, the present applicants shall not be entitled for claiming interest on the enhanced amount of compensation for the period of delay. Civil Applications for condonation of delay in filing cross objections stand disposed of.
