1. Issue notice to the respondents. Learned counsel Mr. Mahesh Patil (Amlekar) waives service of notice for respondents/claimants.
2. Heard learned counsel for the appearing parties. Learned AGP adverts to the contents of the civil applications and contends that it is under those circumstances there is delay in filing first appeals against the land acquisition reference award.

3. Though learned counsel for the respondent purports to resist, veracity of the contents of the application is not over come by any plausible reasons or material contradicting the same.
