view of the said compromise the appeals are disposed of as withdrawn.

3 In view of the compromise refund of Court fees would be as
per rules.

4 Deficit Court fee, if any, be paid forthwith.

5 Pending Civil Applications, if any, be disposed of.

6 Statement is also made that 75% amount is already
withdrawn by the claimants. In view of the fact that interest is to be
calculated as per the decision of the Full Bench in **State of Maharashtra
vs. Kailash Shiva Rangari, 2016 (4) All M.R., 513 (F.B.)** and **State of
Maharashtra vs. Ramesh Tukaram Meshram and another, 2018 (1)**

All M.R., 645. Remaining amount, if any, towards claimants, be given to the claimants and if there is excess amount, then it should be refunded to the acquiring body along with interest accrued.
