PER COURT :

1. The learned Additional / Assistant Government Pleaders appearing in respective writ petitions submit that the learned Advocate General for the State of Maharashtra had made a statement before the principal seat at Bombay in Writ Petition No. 14046 of 2017 with connected writ petitions that the notices issued to the petitioners / co-operative societies under the earlier resolution under which price of milk has been

raised as Rs. 27/- per liter would not be given effect to since the earlier resolution does not survive and the fresh Government Resolution is already issued on 27.09.2018 reducing the price of milk from Rs. 27/- per liter to Rs. 25/- per liter. As the Government Resolution assailed in the present writ petitions do not survive, the purpose of the writ petitions stand served.

2. Writ Petitions stand disposed of accordingly. If the petitioners have any grievance with regard to the fresh resolution, the petitioners are at liberty to take appropriate proceedings. No costs.
