PER COURT :

1. Heard the learned Counsel appearing for the respective parties. Though the learned Counsel appearing for the respondents – claimants has strongly opposed for condoning the delay, after having gone through the contents of the applications, the reasons as are stated in the applications cannot be outrightly rejected. I am, therefore, inclined to allow the present applications. Hence, the following order.

ORDER
