ORDER

01. Learned Advocates for the appellants - acquiring body are present. Learned Asst. Government Pleader Mr. A.M. Phule on behalf of the respondent - State is present. Mr. Nitin Prabhakar Ambhore, Executive Engineer, Osmanabad Medium Project Division, Osmanabad, is also present.

Learned Advocates Mr. M.P. Tripathi, Mr. L.C. Patil, Mr. E.S. Murge, Mr. R.V. Naiknavare, Mr. S.N. Patne, for the respective respondents are present.

02. Statement is made by them, that in this group of matters, in some matters, entire amount is deposited by the acquiring body before the concerned Court or in some matters, either some amount is paid or amount is yet to be deposited. It is covered by Government Resolution dated 03-11-2016 read with subsequent corrigendum dated 23-02-2017 and 13-08-2018 and, therefore, in view of the same, they are intending to withdraw their applications for condonation of delay together with appeals.

03. Further, in view of the decision in *State of Maharashtra Vs. Kailash Shiva Rangari* [2016(4) ALL MR 513 (F.B.)] and *The State of Maharashtra & others Vs. Ramesh s/o. Tukaram Meshram & others* [2018(1) ALL MR 645], the interest would be governed. Matters are also covered by the decision in *The State of Maharashtra, through Collector, Latur & others Vs. Rajasaheb s/o. Digambarrao Desai*, in First Appeal No. 1852 of 2015, dated 18-01-2019.
