1. In all these applications, the applicants/original petitioners pray for bringing the LRs of deceased respondent No. 4/Hanifabee @ Salima Ismail Shaikh, on record.

2. On 07.12.2018, this Court had called upon the learned advocate for the deceased respondent No. 4 to verify as to whether respondent No. 4-A has passed away and whether respondent Nos. 4-B, 4-C and 4-D

are the LRs of deceased respondent No. 4-A/Shaiikh Ismail Fakir Mohammad.

3. It is submitted today on instructions that respondent Nos. 4-A to 4-D are the LRs of deceased respondent No. 4 and respondent Nos. 4-B, 4-C and 4-D are the LRs of deceased respondent No. 4-A.

4. In view of the above, all these Civil Applications are allowed. The delay of 150 days is condoned and the petitioners shall deposit an amount of Rs. 1,000/- per petition with the Government Medical College and Hospital, Aurangabad, **through Medical Officer, High Court Dispensary, Aurangabad**, either in cash or by Demand Draft (Demand Draft be drawn in the name of “**Dean, Government Medical College and Hospital, Aurangabad Dengi Samiti**”) and shall report compliance of this direction by producing a receipt of having deposited the amount, before the Registrar (Judicial) of this Court on/or before 01.02.2019. These LRs shall be brought on record in the Writ Petition on/or before 01.02. 2019.

5. All these three Writ Petitions shall be listed for admission on 12.02.2019.
