2 By this Civil Application, Applicant is seeking condonation of 333 days delay in filing First Appeal and for setting aside the order dated 24.08.2017 passed by Registrar (Judicial-II) by which First Appeal stands dismissed for non-removal of office objections.

3 Considering the submissions made by the learned counsel for the Applicant, the averments made in Civil Application, I am

satisfied that Applicant has made out a case for allowing Civil Application but at the same time Applicant to pay cost of Rs.2,500/-. Hence, following order:

a Delay in filing Civil Application is condoned.

b Order dated 24.8.2017 passed by learned Registrar (Judicial-II) is set aside.

c First Appeal (ST) No.8400 of 2017 is restored on file.
