The respondent No.4 was relieved from the services on the ground that she was not qualified to teach or conduct the course.

The learned Counsel for the petitioner submits that, the Regional Deputy Director, Social Welfare, Pune has observed that the respondent No.4 has done course in LERS and obtained diploma in the year 1997. Whereas in the previous order dated 4th December 2014, the Appellate Authority had not relied upon the

passing certificate of LERS Diploma, since it was issued by the same school wherein the respondent No.4 was a teacher cum secretary during the period the course was allegedly completed.

2] In the light of the above, learned AGP to file affidavit stating whether the certificate/ diploma referred to in the impugned order meets the requisite eligibility criteria and/or whether the same can be considered as requisite qualification. S.O. 8th February 2019.
