3. The present Appeal is directed against the Judgment and Award dated 03.08.2012 passed by the 4th Joint Civil Judge Senior Division, Nashik allowing the Respondents' claim for compensation in terms of the said order.
9. Learned Counsel for the parties state that during the pendency of the Appeal, the matter has been amicably settled and accordingly Consent

Terms are drawn. Learned Advocate for the Respondents tendered Consent Terms.
