3 By these Civil Applications, Applicant is seeking extention of interim protection granted by this court by order dated 21.2.2019.

4 The learned counsel for the applicant

submits that this court (Coram: Smt. Anuja Prabhudessai, J.) by order dated 21.2.2019 granted 3 weeks time from the date of uploading the order.
