2. These Miscellaneous Applications are preferred for withdrawal of the amount deposited by the applicant in the sum of rupees two lakhs, while he was granted permission to travel abroad. The applicant has thereafter complied the order and has traveled abroad and returned back to India.
3. Learned counsel for the applicant submits that in all

these applications, applicant had deposited amount of Rs. two lakhs only. Criminal Application No. 1568 of 2018 had come up for hearing before this Court on 26th of January, 2019. However, the other applications were not listed. This Court had allowed Criminal Application 1568 of 2018 by order dated 26th January, 2019. Learned counsel for the applicant submitted since the other applications were not listed. The order was passed only in respect of Criminal Application No. 1568 of 2018.
