“(c) Pending the hearing and final disposal of this Writ Petition, the execution, operation and implementation of the impugned order dated 8-8-2019 [EXHIBIT “R” hereto] passed by the Respondent No.1 and impugned order dated 18-9-2019 [EXHIBIT “S” hereto] passed by the Respondent No.2 - Institution thereby reverting the Petition in the post of Temporary Clerk, may kindly be stayed and accordingly, the Petitioner be permitted to continue his services in the post of District Organization Commissioner / District Organizer.”

Prayer clause (c) in Writ Petition No.10876 of 2019

“(c) Pending the hearing and final disposal of this Writ Petition, the execution, operation and implementation of the impugned order dated 18-9-2019 [EXHIBIT “U” hereto] passed/issued by the Respondent No. 2- Institution thereby reverting the Petitioner in the post of Temporary Clerk, may kindly be stayed and accordingly, the Petitioner be permitted to continue her services in the post of District Organization Commissioner / District Organizer.”
