1 The Plaintiff's representative and the Defendant No.1 is present in Court.

2 The learned Counsel for the Plaintiff tenders minutes of order which records that the payment has been made by the Defendants to the Plaintiff in full and final settlement of all its claims and demands and captioned Suits shall accordingly stand disposed of as withdrawn.
