 - (a) That the Defendants by themselves, their servants, directors, dealers, distributors, stockists, franchisees, agents, sister concerns, subsidiaries, representatives, affiliates and/or assigns and all persons acting for and on their behalf be restrained by a perpetual order and injunction of this Hon'ble Court from in any manner manufacturing, marketing, selling, distributing, exporting and/or using in relation to medicinal and/or pharmaceutical preparations and/or such allied and cognate goods the trade mark Q LEVO or using any other mark being deceptively similar in any manner whatsoever to

the Plaintiffs mark GLEVO so as to infringe the Plaintiffs' registered trade mark GLEVO registered under No. 1001588 in class 5;

- (b) That the Defendants by themselves, their servants, directors, dealers, distributors, stockists, franchisees, agents, sister concerns, subsidiaries, representatives, affiliates and/or assigns and all persons acting for and on their behalf be restrained by a perpetual order and injunction of this Hon'ble Court from in any manner manufacturing, marketing, selling, distributing, exporting and/or using in relation to medicinal and/or pharmaceutical preparations and/or such allied and cognate goods the trade mark Q-LEVO or using any other mark being deceptively similar in any manner whatsoever to the Plaintiffs mark GLEVO so as to pass off the Defendants' goods as and for those of the Plaintiff.

3. The Defendant hereby declares that it has stock of goods bearing the suit mark as per statement at Annexure A. Defendant undertakes that it shall not manufacture any further goods bearing the suit mark from the date of these terms. Plaintiff has no objection to the Defendant exhausting its stock at Annexure A within a period of 6 months from the date hereof. Defendant undertakes to file affidavit of compliance in the Registry with copy to Plaintiff on or before 20/12/2019.

4. The Defendant hereby agrees and undertakes to withdraw its Trade Mark application No. 1633104 and any other Q-LEVO formative Trade Mark applications that the Defendant might have filed before the Registrar of Trade Marks within a period of 10 days from the date hereof and further undertakes to provide photocopies of the withdrawal application to the Plaintiff's Advocate within a period of 15 days from the date hereof.

The Defendant hereby undertakes and declares that it shall in perpetuity, never challenge the validity of Registration of Plaintiff's trade mark "GLEVO" including any brand extensions containing the word "GLEVO". By consent the order dated 4th July, 2011 in Notice of Motion No.1358 of 2011 is set aside.

6. The Defendant has paid to the Plaintiff vide Demand Draft bearing No. 148455 dated 17-06-19 drawn on RBL Bank a sum of Rs. 1,00,000/- (Rupees One Lakh only) in full and final settlement of all claims of the Plaintiff in the Suit.

7. In view of the above, Plaintiff gives up other reliefs in the Suit.

8. The signatories to these Consent Terms hereby declare that they are competent to sign these terms duly empowered by board resolutions/authorizations.
