1 Plaintiffs and Defendant No.1 have entered into consent terms which in fact contemplates keeping the entire proceedings in abeyance. There are Petitions filed against plaintiff no.1 in NCLT, Ahmedabad, and a resolution professional has been appointed. It is for that reason this consent terms has been entered into. The consent terms is signed by authorized signatory of plaintiff nos.1 and 2 and the Director of defendant no.1. The suit as against defendant nos.3 and 4 has been rejected

and defendant no.2 has not entered appearance.

CONSENT TERMS

1. The above three Suits (i.e. COMS/307/2017, COMS/308/2017 & COMS/545/2017) were filed by the Plaintiffs, *inter alia*, disputing the alleged termination of the Operation and Maintenance Contracts as set out therein in the respective Suit/s. The Defendant No.1 had filed applications in the said Suits for referring the subject disputes to arbitration. Relevant Defendants had also initiated arbitration in accordance with the terms of the relevant contracts, where Plaintiff No. 1 came forward to

participate and had raised preliminary objections to jurisdiction, etc.

2. In addition to the said Suits and interim applications filed therein, applications for reference to arbitration and the arbitration proceedings, Defendant No.1 in three Suit/s had also filed the above-noted ^{Three} Arbitration Petitions under section 9 of the Arbitration and Conciliation Act, 1996.

3. On 26th April 2017, this Hon'ble Court after hearing the parties had orally directed parties to maintain the status quo, i.e., Plaintiffs will continue to provide O&M services and Defendant No.1 will continue to pay the amount for such services. The said understanding is operating till date.

4. However, it was subsequently allegedly observed that the O&M services of the Plaintiffs was not up to the expected standards, which was also the source of the dispute to begin with. Consequently, on 15 May 2017, this Hon'ble Court issued protective orders for the relevant Plaintiffs to undertake immediate repair and maintenance work on the wind turbines and to keep them running in good working condition.

5. On 20th February 2018, the Hon'ble National Company Law Tribunal, Ahmedabad (hereinafter referred to as "**the NCLT**") had admitted an Application No. C.P NO. (TB)

14/7/NCLT/AHM/2018 of 2018 filed by IDBI Bank Ltd. for initiation of Corporate Insolvency Process in respect of Plaintiff No.1. As a consequence of the admission of this application, and by operation of law, a moratorium in accordance with the provisions of Section 13(1)(a) read with Section 14 of the Insolvency and Bankruptcy Code, 2016 (hereinafter referred to as "**the IBC**") was declared with consequential directions.

6. On 19th November 2018 a Resolution Plan (duly approved by Committee of Creditors) was submitted by the Plaintiff No.1 before the NCLT vide Interlocutory Application No. 476 of 2018 in C.P. (I.B.) No.14/NCLT/AHM/2018 ("**said Application**"). The said Application is awaiting adjudication and approval of the NCLT. Once the said Resolution Plan is adjudicated upon and approved and successful Resolution Applicant takes over the management of the Plaintiff No.1, in accordance with the terms and conditions of the Approved Resolution Plan, the parties herein might attempt to amicably settle the subject disputes. The Resolution Professional is desirous of entering into current consent term given that the Corporate Insolvency Resolution Process (**CIRP**) of the Plaintiff No.1 is at a very advanced stage.

7. Therefore, as Plaintiff No. 1 through its Resolution Professional is desirous of settling the present dispute and has requested the Defendants for their cooperation and patience considering that it would be beneficial for all



parties to the dispute to wait for the implementation of the Approved Resolution Plan and the takeover of charge of the Corporate Debtor by the Successful Resolution Applicant, who can then address all issues in a holistic and effective manner. The present Consent Terms are filed in the above captioned matters based on present understanding, i.e., *"that the Plaintiffs will continue to provide Operation and Maintenance services to Defendant No.1 (in each of the aforesaid Suits) and Defendant No.1 will continue to make payment for availing such services on the interim arrangement currently in place as recorded in Minutes of Meeting dated 10th October 2018, till such time Resolution Plan is approved, implemented and a successful Resolution Applicant is in place".*



8. Till such time the above three Suits ~~and Arbitration Petitions~~ and all interim motions shall be kept in abeyance.

Once the final order is passed in NCLT, both parties will apprise the Hon'ble Court of the same and seek further directions. Neither party to this Consent Terms gives up or forfeits any right or contention raised in any proceedings directly or indirectly concerned with the subject dispute, whether in the Suits or Arbitration Petitions or the Arbitrations or Appeals or otherwise. Parties unequivocally agree that the said status quo may not be read to the advantage or prejudice of either party in any pending or future legal proceedings.

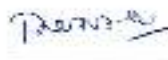

10. Accordingly, the proceedings are adjourned in terms of the present Consent Terms.

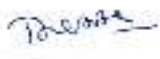

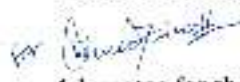

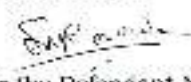
