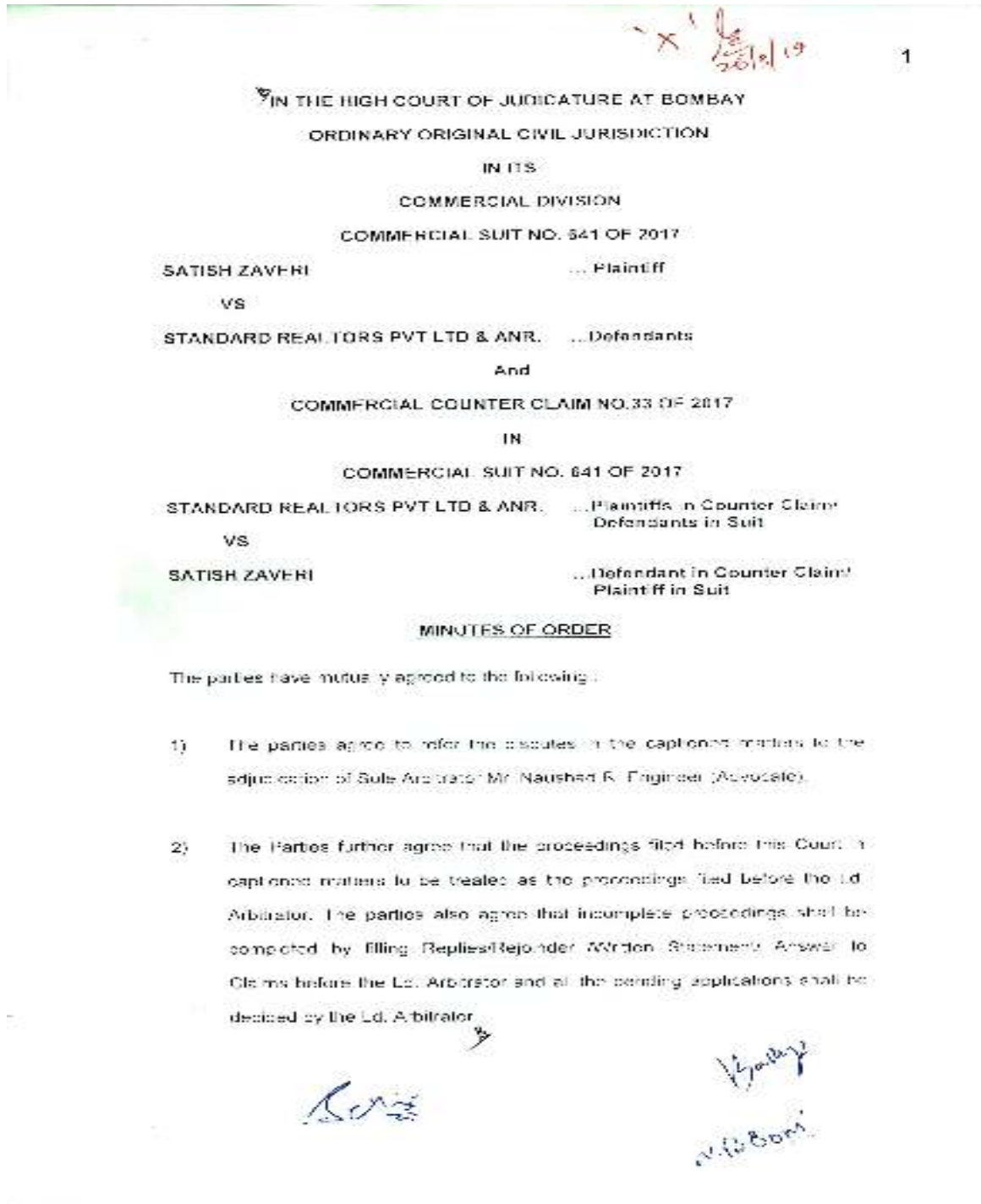

Accordingly, Mr. Naushad Engineer, Advocate practising in this court having his office at 1-D/E, Lentin Chambers, Dalal Street, Fort, Mumbai-400023, Office Nos.66311101 / 22651159, Mobile No.9821047087, email: naushad.re@gmail.com, is appointed as the sole arbitrator to arbitrate on all disputes which are the subject matter of the suit as well as the counter claim. The fees and administrative expenses of the arbitrator to
