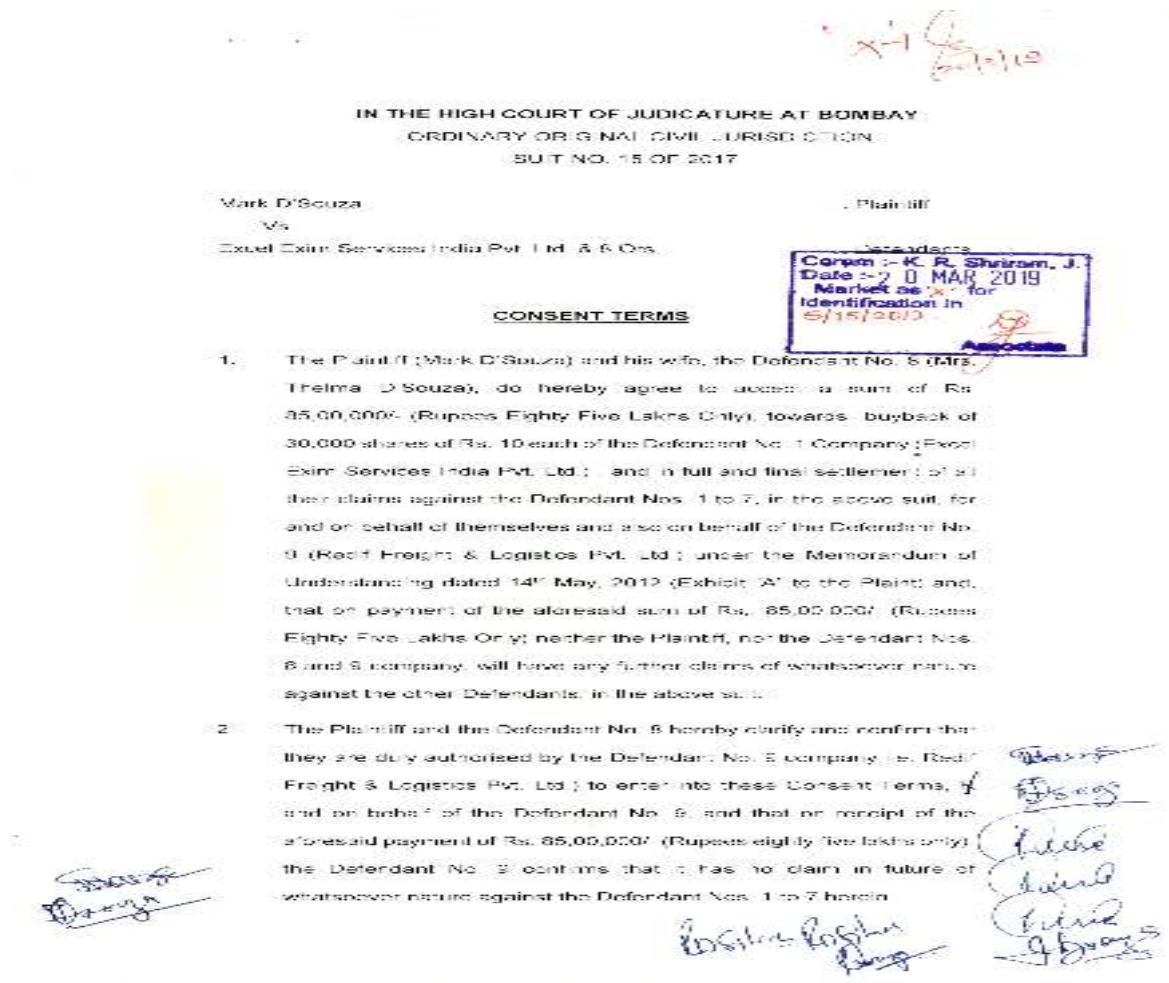

3. The Defendant No. 2 shall within one week from today, pay the aforesaid sum of Rs. 85,00,000/- (Rupees Eighty Five Lakhs Only), to the Plaintiff and the Defendant No. 3, in the following manner:-

- i) a sum of Rs. 42,50,000/- (Rupees Forty Two Lakhs Fifty Thousand Only) by Demand Draft or RTGS, in the name of the Plaintiff (Mark D'Souza), in his HDFC Bank, Powai Branch, Account bearing No. 50100224691444, towards buyback of his 15000 equity shares of the Defendant No. 1 Company bearing Distinctive Nos. 1-10, 11-5000 and 10001-20000 under Share Certificate Nos. 001, 002 and 004 respectively; and
- ii) a sum of Rs. 42,50,000/- (Rupees Forty Two Lakhs Fifty Thousand Only) by Demand Draft or RTGS, in the name of the Defendant No. 3 (Mrs. Thelma D'Souza), in her HDFC Bank, Powai Branch, Account bearing No. 50100224567342, towards buyback of her 15000 equity shares of the Defendant No. 1 Company bearing Distinctive Nos. 5001-10000 and 20001-30000 under Share Certificate Nos. 003 and 005 respectively.

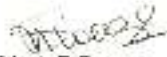
4. On entering into these Consent Terms, and the same being filed on record of this Hon'ble Court, the Plaintiff and his wife, the Defendant No. 5, shall simultaneously hand over their original Share Certificates for the said 30,000 shares, along with the share Transfer Forms and all other documents to effect the share transfer, to Mr. Anandak Davar, the Learned Mediator appointed by this Hon'ble Court, who shall not release the same to the Defendant Nos. 1 to 7, until and unless, full and final payments mentioned in Clause 3 above is

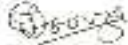

is confirmed by Mr. J.M. D'Silva, the Advocate for the Plaintiff, who shall instruct the Learned Mediator, Mr. Anushak Datta, in writing, to release the said shares and all other documents, to Shri Brian A. D'Lima, Advocate for the Defendant Nos. 1 to 7, for the said transfer to the names of the Defendant Nos. 2 and 3 respectively.

5. The parties withdraw the allegations made against each other. The Plaintiff and his wife (the Defendant No. 8) and the Defendant No. 9 declare that the above amount of Rs. 85 lakhs is in full and final settlement, and there will be no future claims against the Defendant.
6. Decree in terms of these Consent Terms be directed to be drawn up accordingly.
7. Refund of Court Fees, as per Rules.
8. The above suit and the Notice of Motion bearing No. 211 of 2017 be disposed of in terms of these Consent Terms, with the parties to bear their own Advocates' costs.

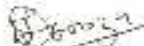
