Vijaya vide proceedings Mu.Mu.No. 44350/ F2/ 2017 dated 02.04.2018 with monetary and all other attendant and service benefits based on the representation of the petitioner dated 28.11.2018.

C O M M O N O R D E R

The grievances of the writ petitioners are that their appointments validly made in a sanctioned post is yet to be approved by the competent educational authority.

2.The 3rd respondent College also sent proposals to the 1st and 2nd respondent on 24.11.2018 and following the same, the petitioners also sent representations on 28.11.2018. However, neither the proposal nor the representations are considered by the competent authorities.

3.Under these circumstances, the 1st and 2nd respondent are directed to consider the proposal submitted by the 3rd respondent / College Management as well as the representations submitted by the writ petitioner on 24.11.2018 and 28.11.2018 respectively and pass orders on merits and in accordance with law within a period of twelve weeks from the date of receipt of a copy of this order. The writ petitioners are directed to enclose the copy of their representations and all other relevant documents, if any, along with the order passed in the present writ petitions.

4.With these directions, both the writ petitions stand disposed of. However, there shall be no order as to costs.
