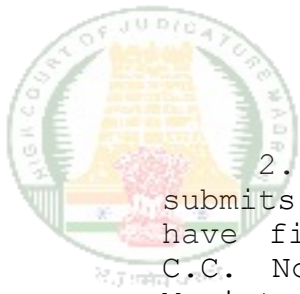

2. The learned counsel appearing for the petitioners submits that, the petitioners are A1 and A2. The petitioners have filed this petition seeking to quash the proceedings in C.C. No. 334 of 2014, on the file of the learned Judicial Magistrate No. II, Chengalpet. It is brought to the notice of this Court that the charge sheet has already been laid and trial is commenced. The petitioners pray that they shall be permitted to face the trial and their appearance shall be dispensed with.
