J U D G M E N T

The order, directing the appellants to regularise the appointment of the 1st respondent as Office Assistant is under challenge, at the instance of the State.

2. When the intra court appeal is taken up for hearing, the learned Special Government Pleader, on instruction, submitted that the Education Department has already approved the appointment of the 1st respondent and as such, nothing survives for adjudication. The said factual position is confirmed by the learned counsel for the respondents also.

3. The intra court appeal is dismissed as infructuous, taking into account the subsequent events as noted above. No costs. Consequently, connected miscellaneous petition is closed.
