When the case is taken up for hearing, the learned counsel appearing for the appellant submitted that he is not pressing the appeal.

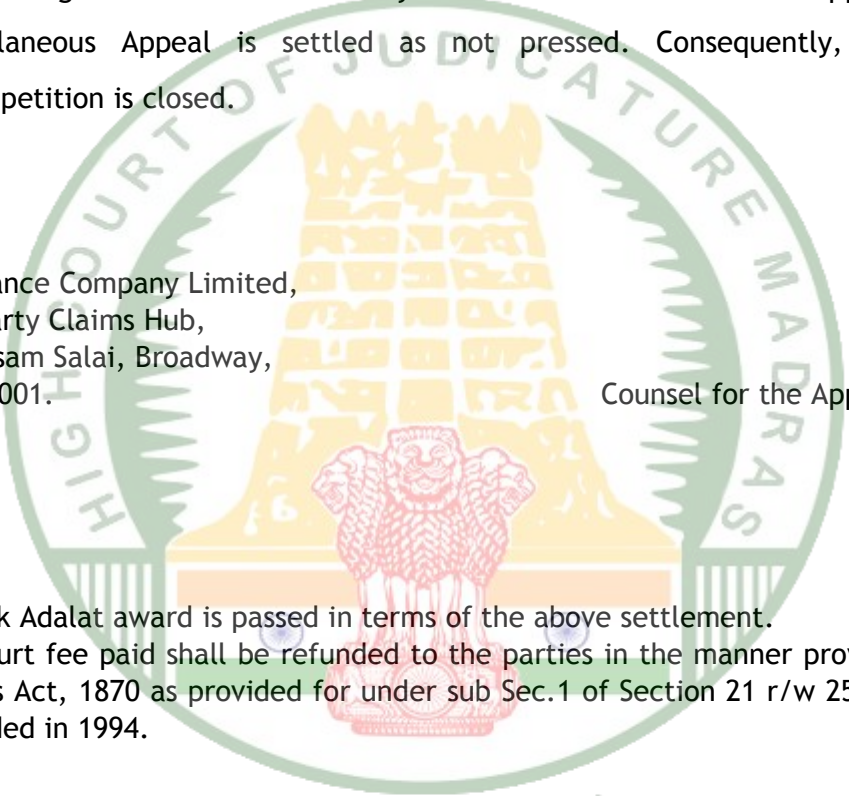

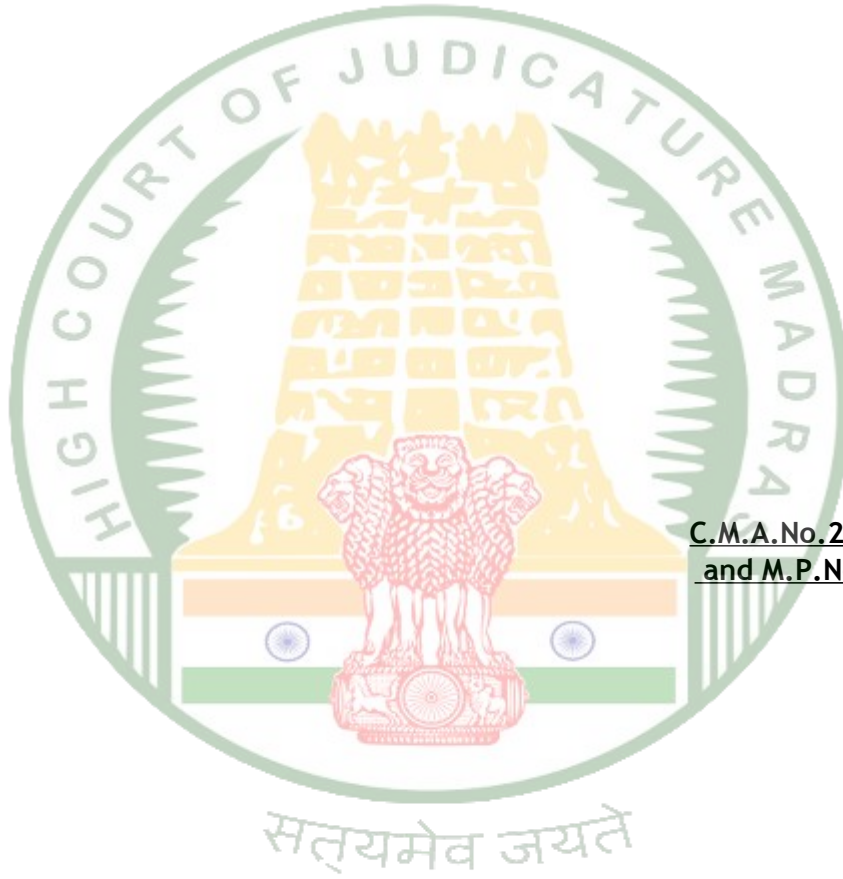
