Single Judge to decide the pending writ petition as expeditiously as possible and till the disposal of the writ petition, the stay order granted by the Division Bench of this Court dated 05.08.2013 shall continue. With the above observations, the Writ Appeal is disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
