Civil Suit coming on this day before this court for hearing, the Court made the following order:-

This Court referred the suit for recording evidence before the Additional Master III. On 15.02.2017, PW1 filed proof affidavit, the Master referred the suit to this Court stating that issues had not been framed. On perusal of records, the suit was referred to the Master for recording evidence without framing issues.

2. Based on the additional pleadings of the parties to the suit, the following additional issues are being framed :

1. Whether the plaintiff is entitled to get the relief of permanent injunction as sought for in the relief (a) in the plaint?
2. Whether the defendants are jointly and severally liable to pay the damages for a sum of Rs.1,00,000/- along with interest at 12% p.a. to the plaintiff?
3. To what relief the plaintiff is entitled to?

3. Registry is directed to list the suit on 22.03.2017, before the Additional Master - III, for recording evidence. Both the Counsel and the parties are directed to appear and cooperate for completing the recording evidence, on or before 27.04.2017.

4. Post the suit before the Court on 28.04.2017.
