COMMON ORDER

The learned counsel appearing on behalf of the petitioner as well as the second respondent/management made a submission that the writ petition was filed against the order dated 17.02.2011 in Unnumbered I.D. of 2010. The workmen/writ petitioners filed the Industrial Disputes claiming that they are the protected workmen. Further the Labour Court rejected their claim and refused to number the industrial dispute. Thus, the writ petitions are filed.

As far as present writ petitions are concerned, no further adjudication is required and accordingly, all these writ petitions are closed. No costs.
