According to the learned counsel for the petitioner the petitioner submitted a representation on 18.12.2018, to the fourth respondent, seeking to issue patta in respect of Survey Nos.22/C/3, 23, 24/3B, 4 at Nos.7, Pazhaverkadu Village and 1/1, 413/1, of V.No.35, Thangal, Perambulam Village, Ponneri Taluk, Thiruvallur District. As the same did not evoke any response, the petitioner has come forward with this Writ Petition seeking for the aforesaid relief.

Considering the facts and circumstances of the case and having regard to the submissions made, without going into the merits of the case, this Court directs the fourth respondent to pass orders on the representation of the petitioner dated 18.12.2018, on merits and in accordance with law, after issuing notice to the petitioner and also affording due opportunity of hearing to him as well as any of the interested parties, within a period of six weeks from the date of receipt of a copy of this order.
