2.According to the respondents, they considered the petitioner's representation dated 20.12.2018 and replied by letter in F/vz;/8_2019_c_ahs;.14.02.2019 issued by the fourth respondent/Assistant Divisional Engineer, Highways Department, wherein it was clearly stated that the subject matter of the land was measured by the department and further action will be taken for removal of encroachment, if any, in accordance with law.

3. In view of the aforesaid statement of the learned Additional Government Pleader, nothing survives for further adjudication in this writ petition. Accordingly, the writ petition is dismissed as infructuous. No costs. Consequently connected miscellaneous petition is closed.
