ORDER

The petitioner has approached this Court being aggrieved by the notice dated 11.12.2018, which is locking and sealing notice in relation to the property situated at Door No.1, Vanchinathan Street, Velachery, Chennai-42. The petitioner is also aggrieved by the notice dated 18.01.2019, which is de-occupation notice in relation to the very same premises.

2. As against both notices, there is a remedy of preferring an appeal and there is also a provision for preferring an application for stay.

3. As the petitioner has efficacious alternate remedy, we are not inclined to interfere with the impugned orders.

4. The writ petition is dismissed. No costs. Consequently, W.M.P.No.2451 of 2019 is closed.
