ORDER:

This second appeal is directed as against the judgment and decree dated 14.09.2005 in AS.No.91 of 2004 on the file of the II Additional Subordinate Judge, Coimbatore confirming the judgment and degree dated 06.07.2004 in O.S.No.1427 of 2001 on the file of the II Additional District Munsif Court, Coimbatore.

2. This second appeal was admitted and pending the second appeal, the matter was referred before mediation and conciliation centre for amicable settlement, and the parties of

3. The above said settlement agreement dated 28.11.2019 shall form part and parcel of this order. Accordingly, the Second Appeal is disposed of. Consequently, connected miscellaneous petition is closed. No costs.
