2.The revision petitioner is the owner of the vehicle being Mahendra Max Pick Up Van bearing Registration No.TN-23-AE-7980. According to the petitioner, no notice was served on him. The prosecution is not able to prove as to whether the notice has been served on the petitioner or not. Therefore, under these circumstances, the respondents are directed to serve the notice on the revision petitioner and take appropriate action in accordance with law.

3.With the above directions, the Criminal Revision Petition is disposed of. Consequently, connected CrI.M.P.No.1204 of 2019 is closed.
