Considering the limited scope of prayer sought for by the petitioner, without expressing any opinion on merit, this Court is inclined to direct the second respondent to consider the petitioner's representation, dated 05.01.2019 on merit and pass appropriate orders in accordance with law, after giving opportunity to the petitioner as expeditiously as possible, preferably within a period of four weeks from the date of receipt of a copy of this order.

6. Accordingly, the writ petition is disposed of with the above directions. No costs.

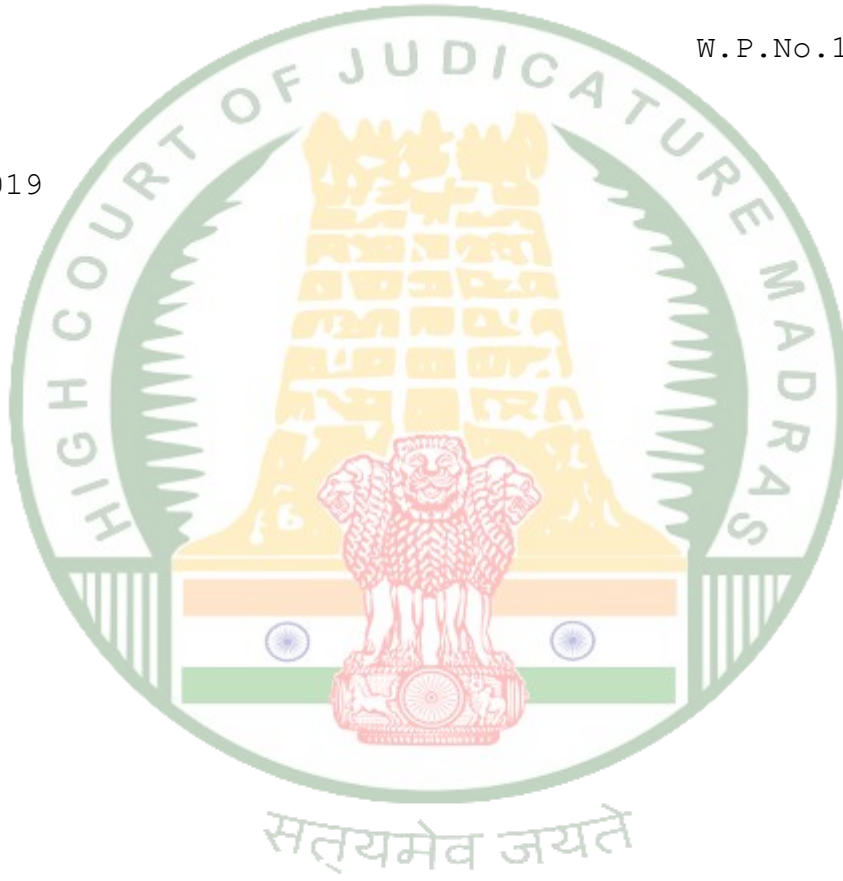
