COMMON ORDER

These writ petitions were listed for "Final Hearing" on 18.10.2019 and none appeared for the petitioner. Thus, these writ petitions were posted under the caption "For Dismissal" on 21.10.2019. When the matters were taken up for hearing on 22.10.2019, there was no appearance on the side of the writ

petitioner. In order to provide one more opportunity to the writ petitioner, considering the fact that the petitioner was appearing in person, again the matters were listed under the caption "For Dismissal" on 23.10.2019.
