This Civil Suit is preferred, under Sections 55 and 62 of the Indian Copyright Act, 1957 read with Order IV Rule 1 of O.S.Rules and Order VII Rule 1 of the Code of Civil Procedure, 1908 seeking a declaration that the plaintiff is the absolute owner of the limited copyrights viz., entire world web-internet Copyrights on a non-exclusive basis, entire cable TV Copyrights & Entire Video Copyrights including

VCD, DVD, Laser disc etc. on sole and Exclusive basis for entire India in the films described in the schedule to the plaint as per the agreement dated 30.03.2004 for a perpetual period; a permanent injunction restraining the defendants, their men, agents, servants or assigns from in any manner infringing the limited copyrights viz., entire world web-internet Copyrights on a non-exclusive basis, entire cable TV Copyrights & Entire Video Copyrights including VCD, DVD, Laser disc etc. on sole and Exclusive basis for entire India and for costs of the suit.

Counsel for plaintiff'

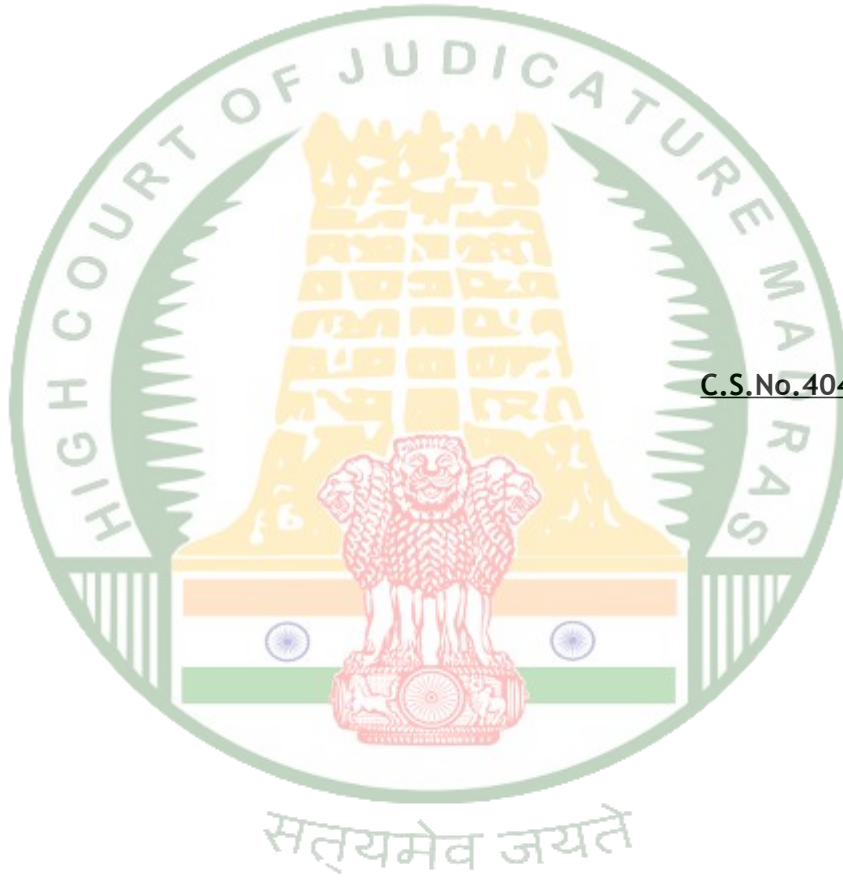
2. Reiterating the aforesaid endorsement, learned counsel also submits, on instructions, that plaintiff is not insisting on refund of Court fees.
