This Civil Suit is preferred, under Sections 55 and 62 of the Indian Copyright Act, 1957 read with Order IV Rule 1 of O.S.Rules and Order VII Rule 1 of the Code of Civil Procedure, 1908 seeking a declaration that the plaintiff is the absolute owner of the limited copyrights viz., Cable TV, rights and Video Copyrights including VCD, DVD, Laser Disc etc., for entire India in the films described in the schedule to the plaint as per the agreement dated 02.11.2000 for perpetual period; a permanent injunction restraining the defendants, their men, agents, servants or assigns from in any manner infringing the limited copyrights viz., Cable TV, rights and Video Copyrights including VCD, DVD, Laser Disc etc., for entire India in the films described in the schedule to the plaint as per the agreement dated

02.11.2000 for perpetual period and for costs of the suit.

2. Reiterating the aforesaid endorsement, learned counsel also submits, on instructions, that plaintiff is not insisting on refund of Court fees.

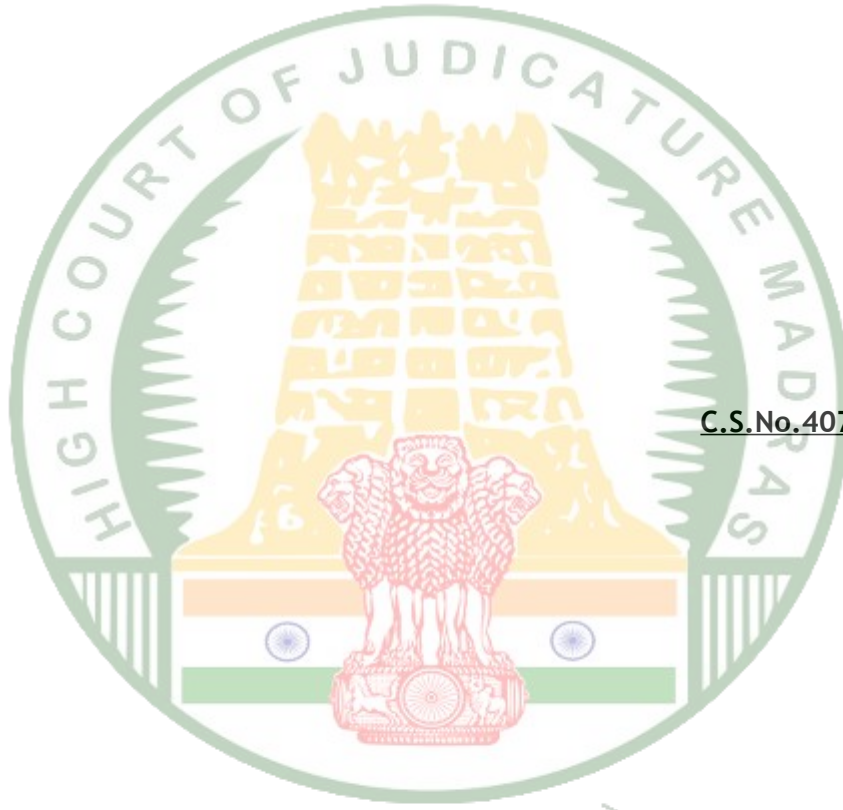
In the light of the aforesaid endorsement in the suit file and reiteration of the same, this suit is dismissed as withdrawn. There shall be no order as to costs.
