Prayer in WP.No.39335 of 2003 : Petition filed Under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, calling for the records of the 2nd respondent relating to his letter dated 28.11.2003 in Na.ka.9119/94/A3 and quash the same with a direction to the 2nd respondent to pass an award under Section 12 of the Land Acquisition Act (Central Act) after permitting the petitioner to take part in the enquiry under Section 9(3) and 10 of the Land Acquisition Act of 1894, i.e. (Central Act), in the impugned proceedings of the 2nd respondent in Na.Ka.9119/94/A3 dated 28.11.2003.

Prayer in WP.No.2822 of 2002 : Petition filed Under Article 226 of the Constitution of India praying to issue a Writ of Certiorari, calling for the records of the 2nd respondent pertaining to the G.O.Ms.No.1357 (Public) Telephone-2) dated 11.12.2001 and in respect of the land in S.No.65/1 and 65/2 situate in Porur village, Ambattur Taluk, Thiruvellore district measuring 0.48.5 hectares.
